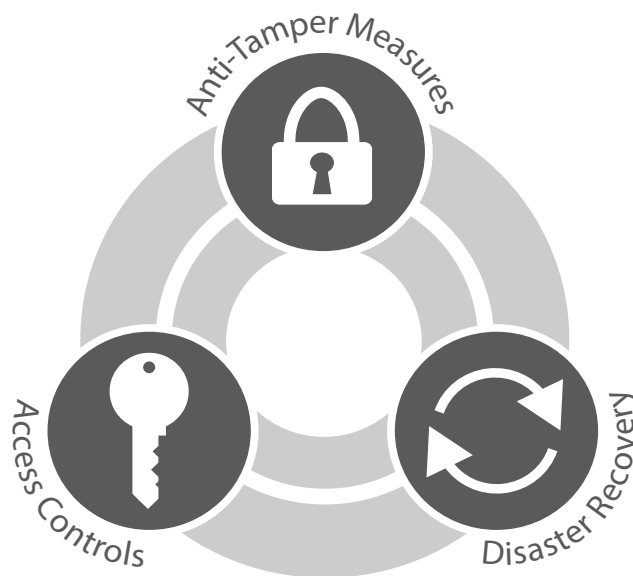

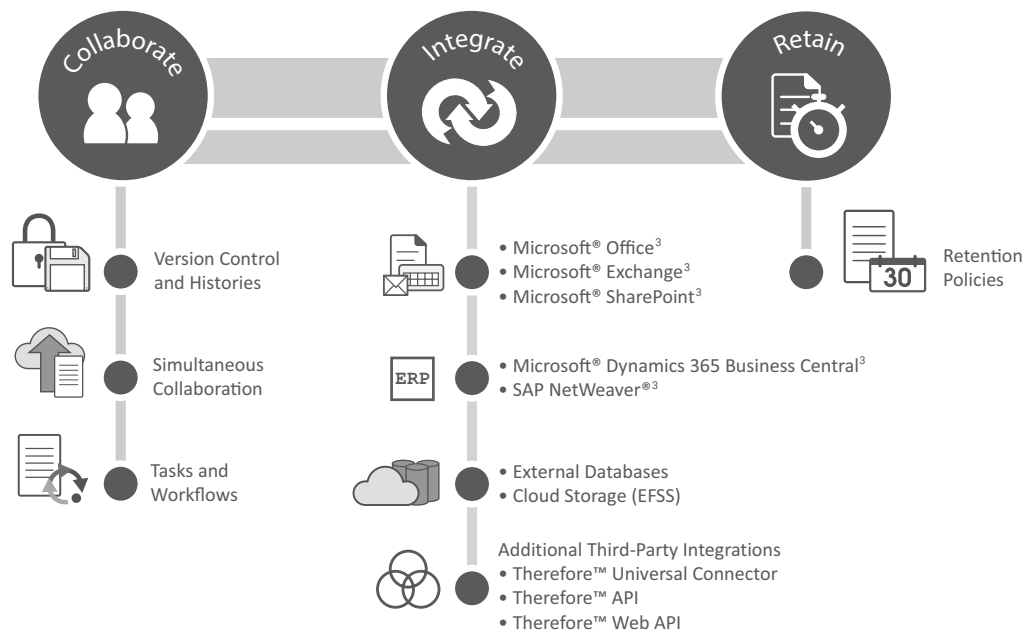
- **CONTROL** user access to the system
