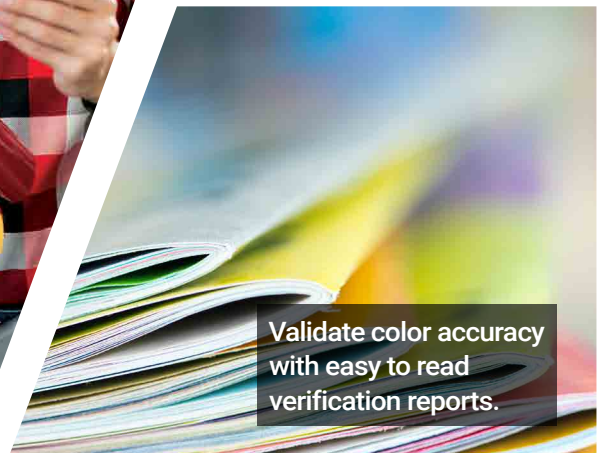

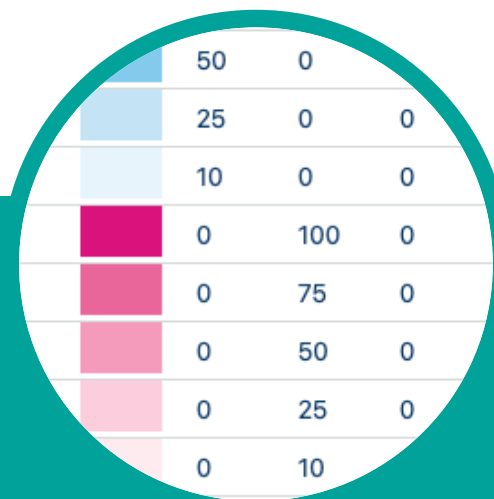

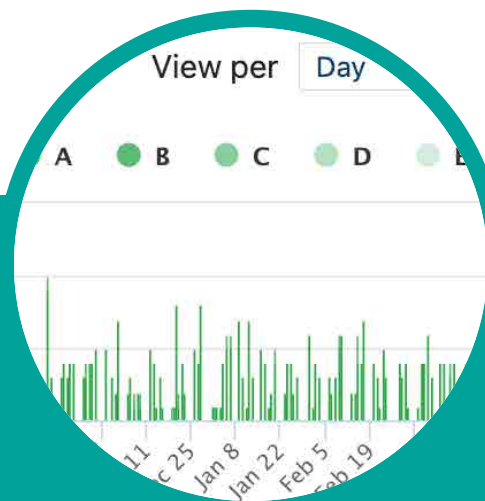

Move color judgment from subjective visual assessment to objective reporting using the power of digital measurements. Validate results against industry standards or your organization's predefined tolerances.

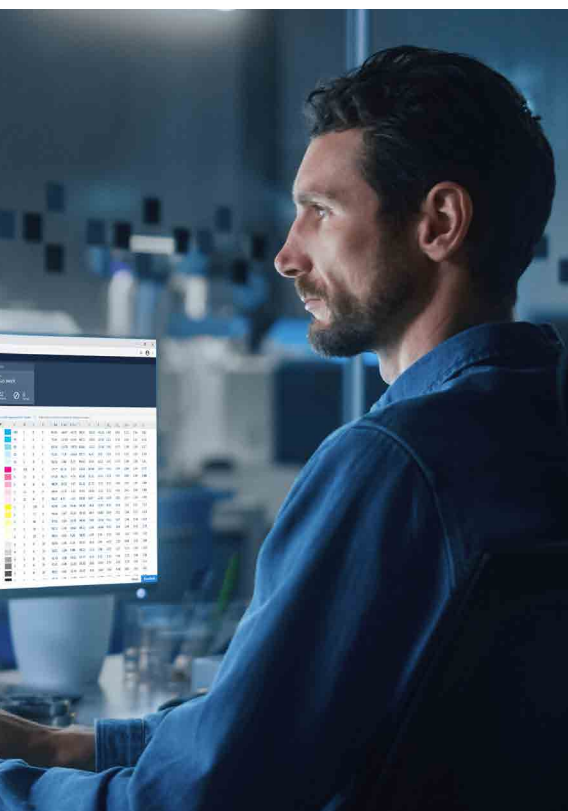

# MAINTAIN CONSISTENCY

## MEASURE

Measurement is one of the key first steps to a color management workflow. With a few simple clicks, operators can quickly output a color measurement chart which can then be read for validation.



## VALIDATE

Color management doesn't end there, however. With the validation results, operators within an organization can use this data to determine next steps, if any, and help identify the condition of the printer.



## ANALYZE

Once the measurement chart is printed, the color patches are read in for validation to an industry standard color reference. Validation is what compares your output to the standard.



## TREND

Trending is the final step of color control, where an organization can monitor the health of the printer over time with easy to read reporting and analysis.
