





Dedicated to helping enrich the lives of all people through technology and Universal Design, Canon's MFP Voice Assist, a MEAP application available as an add-on to Authorized Send, aids users with visual impairments and/or those who may have difficulty using the touch panel. Using voice commands, users can easily perform device operations such as basic copy, print, and scan features on supported Canon imageRUNNER ADVANCE DX, imageFORCE, and imagePRESS Lite multifunction printers.

MFP Voice Assist consists of the following:

- MFP Voice Assist MEAP Application installed on a supported MFP (Fee-based Add-On to Authorized Send)
- MFP Voice Assist iPad Application (Free Download)





Required Parts*

- iPad
- · Stand (Table or Floor)
- · Cables (Lightning to LAN and LAN to USB)

How It Works

- · Start Authorized Send on the MFP.
- Touch the iPad® screen and say a command, like
 "Make three color copies double-sided and stapled."**
- MFP Voice Assist displays the command as text and recites it back to the user. Once the user confirms the command, it's then sent to the compatible imageRUNNER ADVANCE DX, imageFORCE, or imagePRESS Lite device to be carried out.
- The device can perform the functions listed in the chart below using voice commands.

Hardware Requirements


- Supported on Canon imageRUNNER ADVANCE DX, imageFORCE, and imagePRESS Lite devices with the latest released firmware.*
- Requires a USB to Ethernet adapter** for the subline connection between the Canon device and the iOS device. Supported USB adapters include those listed below.

- The Voice Operation Service iOS component is supported on all Apple® devices running iOS 15 or later or iPadOS 15 or later.
- For iOS devices with a USB-C port, a USB-C to Ethernet adapter is required.**
- For iOS devices with a lightning cable port, a lightning to Ethernet adapter is required.**
- An RJ45 Cat 5 (or greater) Ethernet cable* connects the iOS device to the MEAP device.

Software Requirements

- MEAP serverlet configuration requires a computer with the latest Microsoft Edge, Firefox, or Google Chrome browser (all with JavaScript enabled).
- The iPadOS device must run iOS/iPadOS 15 or later.
 You must have a valid Apple ID and access to the Apple Store.



- MFP Voice Assist speech detection times out after a short period of silence. To end the detection immediately after speaking, press the microphone button again.
- MFP Voice Assist allows users to make copies without having to log in to Authorized Send. MFP Voice Assist uses the default "Scan" and "Print" settings preprogrammed in Authorized Send to make the copies.
- Not all Authorized Send features and functions are supported by MFP Voice Assist. Refer to the "Authorized Send User's Guide" for information on supported features.
